

#### Affordable Connectivity Program Update

The Affordable Connectivity Program (ACP) is a Federal Communications Commission (FCC) program that replaced the Emergency Broadband Benefit Program (EBB Program) to help low-income households pay for internet service and connected devices.

As of the printing of this newsletter, the Affordable Connectivity Program will stop accepting new applications and enrollments on February 7, 2024. Consumers must be approved and enrolled with a service provider before 11:59 p.m. ET on February 7 to receive the ACP benefit.

Households who have applied, been approved, and are receiving the monthly internet discount before February 8, 2024 will continue to receive their ACP benefit until ACP funds run out, as long as the household remains enrolled in the program. After the ACP funds run out (projected in April 2024), households participating in the ACP will no longer receive the ACP discounts.

If additional funding is passed in Congress, we will update you next month on the status of the program.

#### **Board of Director Announcement:**

At this time, we are already underway planning for our 2024 Annual Meeting. The meeting is scheduled for Friday, April 5 at the Hamilton County Senior High School Gym in McLeansboro. This year the Belle Prairie (648) and Macedonia (728) exchanges will be up for Director Elections.

According to the HCTC By-laws, the nominating committees for the Belle Prairie (648) and Macedonia (728) exchanges have been selected by the Board of Directors. It is the responsibility of the nominating committee to select at least one certified nominee for Director to represent their exchange for a three year term. The nominating committee for the 648 exchange made the nomination for their exchange for nominee Alan Monroe to serve another three year term on the HCTC Board. The nominating committee for the 728 exchange made the nomination for their exchange for nominee Chris Sink to serve another three year term on the HCTC Board.

Although the nominees as candidates are selected by these committees, the by-laws also allow for any other certified member of these exchanges the same right in running and serving a three year term as Director for their exchange. If you are interested, you can pick up a petition (required to be signed by 10% or 15 certified members, whichever is less, of your exchange) at the co-op from the General Manager, along with the specific details and requirements of serving as a Director.

You will have until March 15th to file your certified petition with the Co-op for your name to be placed on the ballot at the annual meeting. If you are not the nominee selected by the committee and would like your name printed in the annual meeting booklet, you will need to file your petition by February 15th due to the printing lead time requirements.

We look forward to seeing you at the Annual Meeting in 2024.
